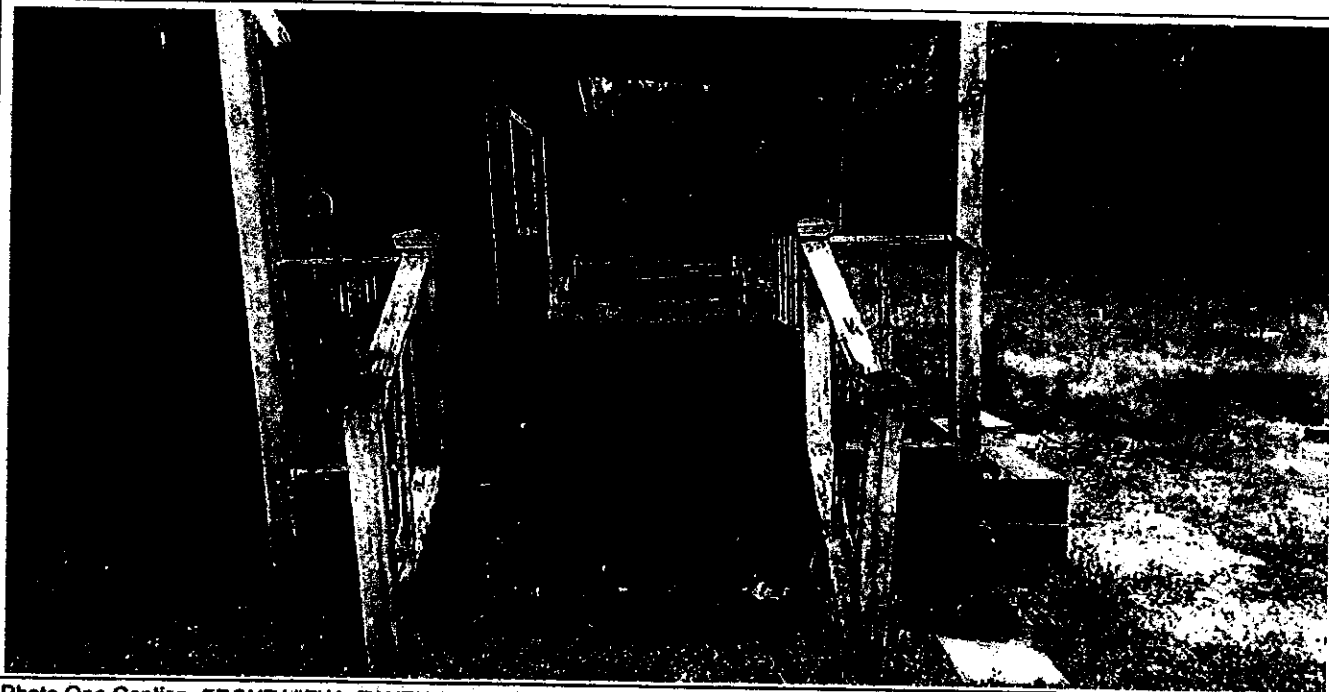


Photo One Caption FRONT VIEW - TAKEN 04/21/2018

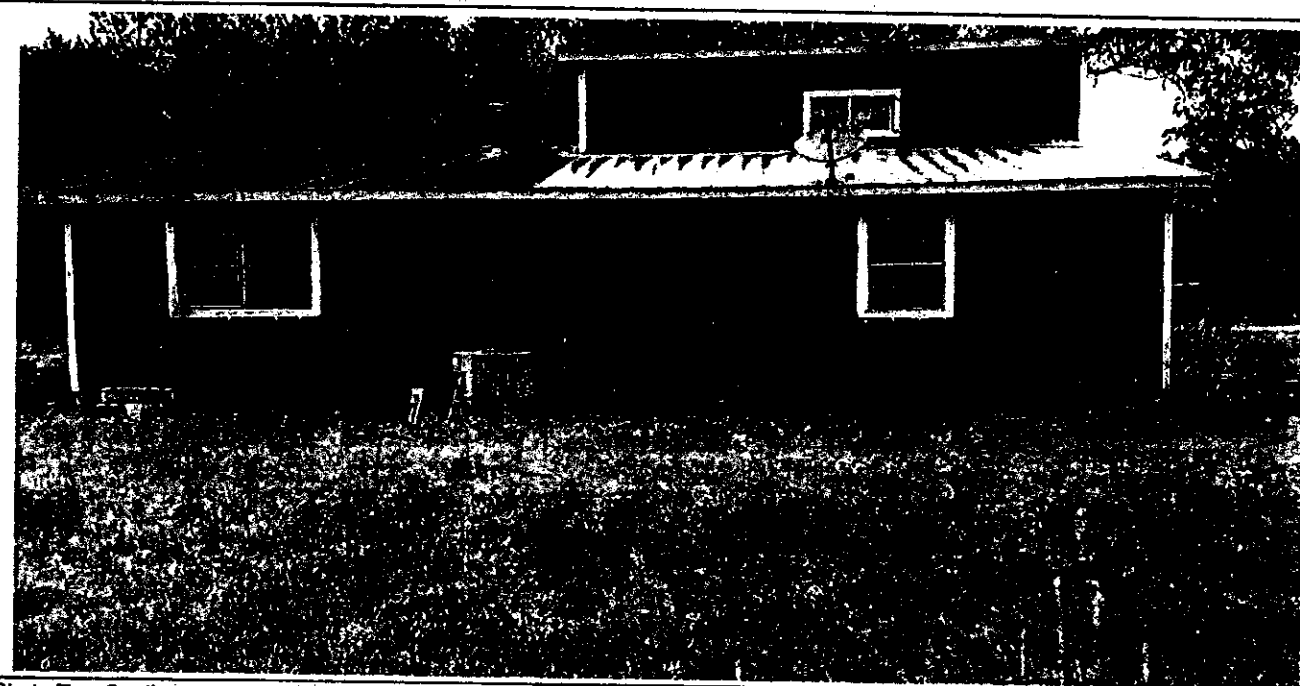


Photo Two Caption REAR VIEW - TAKEN 04/21/2018

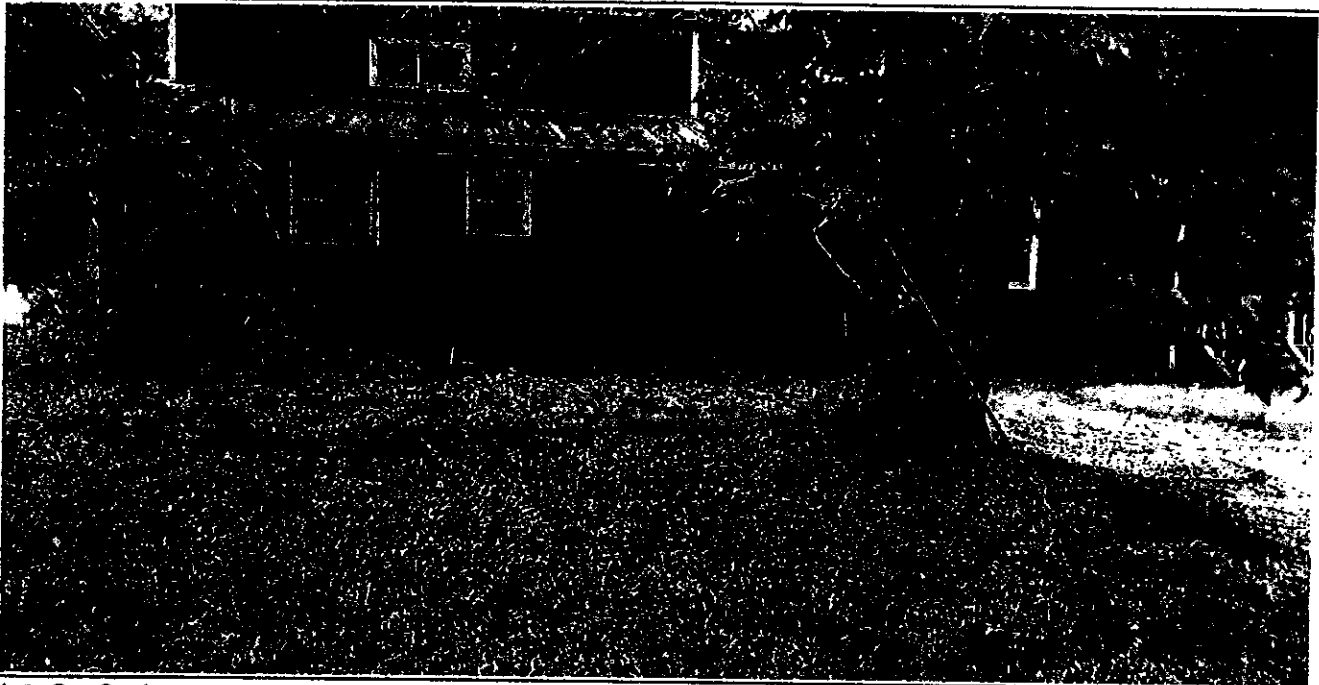


Photo One Caption LEFT SIDE VIEW - TAKEN 04-21-2018
